In consideration of the length of consecutive accounting years of the current accounting auditor, and the audit response and the reasonableness of audit costs aligned with the business scale of the Company, we received and compared the proposals of multiple audit firms. Based on the reason in 3. above, the Company will propose the election of Seiryo Audit Corporation as its new Accounting Auditor.
